2018 AOPA FLY-IN "FARTHEST FLIGHT" CONTEST AT SANTA FE, NM OFFICIAL RULES

- 1. No purchase necessary to enter or win this contest.
- 2. **Eligibility**: Contest is open to all pilots who fly an aircraft to the AOPA Fly-In at Santa Fe, NM on September 14-15, 2018 who are eighteen (18) years of age or older as of that day. The contest is not open to employees of AOPA, their families, agencies, or suppliers. The contest is open to AOPA volunteers. Minors as determined by their jurisdiction of residence may not participate without the consent of a parent or guardian.
- 3. **Prizes**: There is one (1) **grand prize**. The **grand prize** is:
 - a. A one-year U.S. Standard subscription to Garmin Pilot™ and a Lightspeed Zulu 3 Headset. Total ARV of all prizes \$924.99.
- 4. Contest Criteria: The Winner will be the pilot-in-command who flew an aircraft the greatest straight-line distance from the point of original departure to Santa Fe Municipal Airport (KSAF) to attend the 2018 AOPA Santa Fe Fly-In determined as follows: During the AOPA Pilot Town Hall held at approximately 3:00 p.m. at the "Main Stage" at KSAF on September 15, 2018, an AOPA employee or designee will ask attendees to identify the pilots in command having flown the farthest. The actual straight-line distances flown will be the straight line from the original departure airport to KSAF, as calculated by the Garmin Pilot application. The first eligible pilot will be awarded the grand prize. In the event of a tie, the winner will be determined by random drawing from the eligible winners. Winner must be present at the Pilot Town Hall to win. In the event winner is not present he/she will be disqualified and an alternate winner will be determined.
- 5. Void where prohibited. Subject to all federal, state and local laws.
- 6. Miscellaneous: By entering this contest each participant agrees to be bound by these Official Rules and the decisions of AOPA and its judges/agents, whose decisions regarding all aspects of the contest shall be final. Each participant agrees that any and all disputes and causes of action arising out of this contest shall be resolved individually and any judicial proceeding shall take place in a federal or state court within the State of Maryland. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of participants and AOPA in connection with the contest, shall be governed by and construed in accordance with the laws of the State of Maryland, without giving effect to any choice of law or conflict of law rules or provisions (whether of the State of Maryland or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than the State of Maryland. All federal, state and local taxes, fees and other expenses are winner's responsibility. Each winner shall grant permission to AOPA, its subsidiary and affiliated businesses to use his or her name, age, city, state, and photograph or other likeness for advertising and promotional purposes without additional compensation, except where otherwise provided by law.
