

AOPA’s “2023 Pilot Passport: Most in May Challenge” Contest Official Rules

By participating in the 2023 Pilot Passport: Most in May Challenge, you agree that you have read, understand, and accept all of the following Official Rules and terms:

WHO MAY ENTER:

Open to all individuals who legally reside in the 50 United States, the U.S. Virgin Islands and the District of Columbia 18 years of age or older who are the holders of a current FAA-issued student, sport, recreational, private, commercial, or ATP airman certificate. Employees of AOPA, its subsidiaries and affiliated companies, and the trustees, officers, directors, interns, advertising or promotion agencies of each, are not eligible to win. Any person in the immediate family of an employee (including the spouse, children, parents, brothers and sisters of any employee) living in the same household of any such employee is not eligible to win. Individuals who have won a total of two or more prizes (grand prize, second prize, or third prize) in 2022 and/or 2023 Pilot Passport challenges are not eligible to win this challenge.

ENTRY DEADLINE:

The contest begins at 12:00 AM Eastern Time on May 1, 2023 and ends at 11:59:59 PM Eastern Time on May 31, 2023 (the “Entry Period”). All entries must be completed during the Entry Period.

HOW TO ENTER:

To enter, utilize the “Pilot Passport” feature within the AOPA Pilot Passport App to check-in to airports in the United States listed in the App during any day(s) the Entry Period.

Each participant will receive one entry for each airport check-in per day; participant cannot check-in to the same airport more than once per day.

As described below, three participants with the most entries (i.e., most airport check-ins) in any one day of the Entry Period will be the Grand Prize winners.

NOTE: AOPA Pilot Passport App functionality is dependent upon an internet connection which may not be available at all locations.

JUDGING:

Three participants with the most entries (i.e., most airport check-ins) in any one day of the Entry Period will be the Grand Prize winners. In the event of a tie, AOPA may select the Grand Prize winners by random drawing from the eligible winners. AOPA reserves the right to: (a) disqualify any individual entry that appears in AOPA’s sole discretion not to conform to the technical letter or spirit of these rules; and/or (b) disqualify any individual contestant that appears in AOPA’s sole discretion not to conform to the technical letter or spirit of these rules. Grand Prize winners will be notified via email, postal service, or phone.

PRIZES:

There will be three (3) Grand Prize winners. The Grand Prize winners will each receive a Pilot Workshops Airplane Engine Manual. Approximate retail value (“ARV”) of each Grand Prize is \$450.00. ARV of all Grand Prizes is \$1350.00.

LIMITATIONS AND DISPUTES:

By entering the challenge, you agree to release and hold harmless the Aircraft Owners and Pilots Association and its employees, officers, and directors, and agents from any claims, allegations, penalties, damages, and legal fees that may arise, directly or indirectly, from your participation in this challenge. Each participant agrees that any and all disputes and causes of action arising out of these rules or this contest shall be resolved individually and any judicial proceeding shall take place in a federal or state court within the State of Maryland. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of participants and AOPA in connection with the contest, shall be governed by and construed in accordance with the laws of the State of Maryland, without giving effect to any choice of law or conflict of law rules or provisions (whether of the State of Maryland or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than the State of Maryland. All federal, state and local taxes, fees and other expenses are winner’s responsibility. By entering this contest each participant agrees to be bound by these Official Rules and the decisions of AOPA and its judges, whose decisions regarding all aspects of the contest shall be final.

By entering the challenge, you grant the Aircraft Owners and Pilots Association a non-exclusive, royalty-free, irrevocable license to publish, display, and otherwise use the names and likenesses of the winners, in print or electronic form on AOPA electronic media and/or in a future issue or issues of print publications, for advertising and promotion of AOPA.
