The Aircraft Owners and Pilots Association (AOPA) is a not-for-profit membership organization that represents the general aviation interests of over 400,000 members nationwide, including nearly 6,300 in Oregon. Since 1939, AOPA has been committed to ensuring the safety, future viability, and development of general aviation airports and their facilities as a part of our national transportation system.

As the Oregon Transportation Commission considers grant applications received under the ConnectOregon IV transportation improvement program, AOPA strongly encourages the Commission to fund the 22 project applications that benefit general aviation activities in the state.
