AOPA's "2023 Pilot Passport: March Lucky Badges Challenge" Contest Official Rules

NOTE: AOPA Pilot Passport App functionality is dependent upon an internet connection which may not be available at all locations.

JUDGING:

The top three participants, with the most badges earned, as indicated by the Pilot Passport feature during the Entry Period, will be the Grand Prize winners. In the event of a tie, AOPA may select the Grand Prize winners by random drawing from the eligible winners. AOPA reserves the right to: (a) disqualify any individual entry that appears in AOPA's sole discretion not to conform to the technical letter or spirit of these rules; and/or (b) disqualify any individual contestant that appears in AOPA's sole discretion not to conform to the technical letter or spirit of these rules. Grand Prize winners will be notified via email, postal service, or phone.
