

## AOPA's 2017 TAMPA FLY-IN ICON A5<sup>®</sup> DEMO RIDE SWEEPSTAKES OFFICIAL RULES

1. **NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**
2. **WHO CAN ENTER:** The sweepstakes is open to all individual addressee/recipients of the AOPA Media Update Newsletter (the "Eligible Participants") who are 21 years of age or older as of the date of entry who will attend AOPA's 2017 Tampa, Florida Fly-In on October 28, 2017 and who legally reside within the 50 United States, District of Columbia, Puerto Rico, or U.S. Virgin Islands. The sweepstakes is not open to employees of AOPA or its subsidiaries and affiliated companies ("Employee"). Any person in the immediate family of an Eligible Participant or any Employee (including the spouse, child, parent, brother and sister of any Eligible Participant or Employee) living in the same household of any such Employee is not eligible to win.
3. **WHAT CAN I WIN:** The grand prize is a demonstration ride in an ICON A-5<sup>®</sup> aircraft with a factory demo pilot at the AOPA 2017 Fly-In in Tampa, Florida on October 28, 2017 at approximately 3:00 PM. There is one (1) grand prize that will be awarded. The approximate retail value of the grand prize is \$0.
4. **HOW DO I ENTER:** The sweepstakes begins at 2:00 PM on October 20, 2017 and ends at 8:00 PM on Wednesday, October 25, 2017 (all times are Eastern Daylight Time) (the "Promotion Period"). Enter by posting a photograph and short description of what and where your ideal experience in and ICON A5 would be, using the hashtag #AOPAFlyIn and #FlyICON on Facebook and/or Instagram] during the Promotion Period. Limit: one (1) entry per Eligible Participant. Odds of winning are determined by number of participants.
5. **HOW DO I WIN:** Winner will be determined by random drawing from all eligible entries during the Promotion Period. Drawing will take place at approximately 8 PM on or about October 25, 2017. Winner will be notified by email and/or direct message on social media. Winner must be present at the ICON exhibit at the AOPA 2017 Tampa Fly-In fifteen (15) minutes prior to the specified time to receive the demo ride. Note that there is a passenger weight limit of 250 pounds.
6. **GENERAL:** Winner agrees to be photographed by AOPA and/or ICON Aircraft, Inc. and have his/her name and likeness used by AOPA at its sole discretion for the purposes of promoting the sweepstakes and the AOPA fly-ins. By entering the sweepstakes, entrants grant the Aircraft Owners and Pilots Association a non-exclusive license to publish, display and otherwise use submitted print and/or photo materials, in print or electronic form on AOPA electronic media and/or in a future issue or issues of print publications, and for advertising and promotion of AOPA and for exhibition. Any such uses will include appropriate credit to the submitter. Submitted materials must be original and authored/created by the submitter and entrants agree not to submit materials that do not meet these criteria. For a photo in which a person is recognizable, you must provide upon request a **model release** and/or **property release** from the subject or, in the case of a minor, the subject's parent or guardian and/or property owner. You can print a model release and/or property from our Web site. Winners are solely responsible for any taxes that may be payable as a result of winning. Winners may be required to confirm his/her identity, eligibility and address. If a potential winner declines to accept the prize, or is not present at the AOPA 2017 Fly-In in Tampa, Florida at the specified time, the potential winner may be disqualified and AOPA may select an alternate winner. By participating in the sweepstakes, all participants agree to be bound by these Official Rules and the decisions of AOPA and its employees, whose decisions regarding the sweepstakes shall be final. Winner agrees that the prize is awarded without any warranties, expressed or implied, and AOPA disclaims such warranties and the time for the demo ride may be altered or cancelled in the event weather or some other circumstances prevent the safe conduct of the ride in the opinion of the ICON demo pilot. There is a passenger weight limit of 250 pounds. Winner further agrees to hold harmless the officers, directors and employees of AOPA and ICON Aircraft, Inc., their families, heirs and assigns from any and all injuries or damages arising out of the use of the prizes.
8. DISPUTE RESOLUTION. Each participant agrees that: (a) any and all disputes, claims, and causes of action arising out of or in connection with this Sweepstakes, or any prize awarded, shall be resolved individually, without resort to any form of class action and any judicial proceeding shall take place in a federal or state court within the State of Maryland; (b) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event shall such damages include attorneys' fees; and (c) under no circumstances will a participant be permitted to obtain awards for, and each participant hereby waives all rights to punitive, incidental, or consequential damages, or any other damages other than actual out-of-pocket expenses.
